As a significant segment of the population have been forced to remain in their houses, we have become painfully aware of the need to have decent living spaces that allow us to maintain our physical and mental health and livelihoods.

Moreover, for those who cannot currently stay at home due to multiple reasons, houses still demand access to services and proximity to our workplaces in order to avoid, as possible, the risk of infection.

Finally, we have seen the disproportionate impacts of housing precariousness, overcrowding, and homelessness on vulnerable populations, which increases and accelerates our exposure to the negative effects of the pandemic. Hence the urgent need to build sustainable cities and communities.

Fortunately, since 2016, with the adoption of the New Urban Agenda, the United Nations Member States and agencies have had a clear direction on how to ensure that all people have access to adequate housing and basic services.

Undoubtedly, there are still many issues that need to be addressed related mostly to improving governance, ease of access to financing, and enhancing capacity building. Nonetheless, I believe governments, private sector and civil society have become more aware and responsive to finding ways to promote and implement innovative urban solutions.

Above all, you are an inspiration to all of us to take action.
